SEM Plan & ARC

- Tara Sprehe provided an update on the SEM plan and discussed with the group where SEM can fit into ARC work/structure.

- Questions and answers about the SEM plan and how it fits into ARC:**
- Where does the SEM work fit into the larger strategic plan?
 - A: Developing a SEM plan and then monitoring the progression.
 - Chris how often do you see the KEI’s needing to be updated?
 - A: Typically, they are updated every 2 -3 years.
 - How do we integrate SEM planning into the work and structure of ARC?
 - Is there a natural way to roll that work into this group?
 - How do we make sure that we are all moving in the same directions?
 - As we understand ARC in its current structure how might we own the SEM plan?
 - Do we need a different structure? Or is it the work of the group.
 - Is the goal for this group to develop a SEM plan or build out the goals, tactics, and strategies of the plan?
 - Currently, we don’t have a full SEM plan. What we have is a set of data and identified Key Enrollment Indicators (KEI’s) that sets the foundation for a SEM plan. There is a direct connection between a SEM plan and the work of ARC. The question is can ARC be the place to develop the plan?
 - Once developed, the plan would have goals, a strategies, and tactics for each KEI that need to be developed.
 - The SEM committee work was practice for the future SEM Plan work.
 - Suggestion: Should we restructure the ARC subcommittees to help develop a SEM plan going forward?
 - There was some discussion about the potential to restructure the subcommittees or re-focus their work based on the KEI’s.
 - Is there a new structure that people have in mind?
 - Maybe there is an opportunity for subcommittees to connect with other subcommittees to help advance the work.
 - Adam Wickert - Can we focus on how each subcommittee could focus on individual tactics in service to the SEM plan?

What if we could give feedback about what faculty are doing to help move the needle? • What data should we use as we think about being responsible for developing goals, tactics, and strategies for the KEI's? Data is hard for us to access. • Jim stated in Chat: we need to remember to do some assessments after implementation. Sometimes we forget to check back in after 6 months or a year to make sure the new plan/process/software is working. ARC could help that piece of it as well.

- We need to have a way to strategically figure out what barriers are out there within the college processes. We have been working on discussing financial barriers since ARC FRS has been established, but we need to have a system of identification and addressing of barriers. Additionally, there will be barriers to retention above and beyond financial
