2. gather GPS data from NW plate boundaries, analyze the data and create a hypothesis concerning plate motion in the NW; (SC1)(SC2)(WR1)

3. apply information gathered about tectonic plate interactions in the Northwest United States to hypothesis about volcanic activity and volcanic hazards that affect Oregon and Washington, (SC1) (SC3)

4. discuss weathering processes on Earth and how these processes control sedimentary rock formation and soil formation, (SC1)

5. predict, using the uniformitarianism model, past geological surface conditions based on the sedimentary rocks and structures found in a region; (SC1)

6. explain how the interior of the Earth is structured and know what the physical and chemical properties are for each region, (SC1)

7. explain the theory of plate tectonics and why this model of plate interaction is a underlying foundation for the science of geology, (SC1)

8. explain how the Earth's plates interact at different plate boundaries, what geological features are found at each type of boundary and how the structures produced affect society with regards to mineral resources and geological hazards; (SC1) (SC3)

9. apply scientific methods to gather information about the properties and attributes of rocks in order to correctly identify unknown samples, (SC2)

10. scientifically gather information about the properties and attributes of minerals in order to correctly identify unknown samples, (SC2)

11. use the scientific method to observe natural settings, identify the rocks and minerals in these settings and use the evidence gathered to hypothesis about the geological system that formed the observed lithology; (SC2)

12. explain how the geological sciences interact with society and how those interactions relate, both positively and negatively to environmental sustainability; (SC3) (SC1)

13. discuss the various uses and importance of minerals in society and know which mineral provides which ore,


