Course Title: COBRA/Weapons of Mass Destruction DOJ Incident Command

Course Description:

This course serves as an introduction to weapons of mass destruction (WMD) threats: chemical, biological, radiological and nuclear and the toxicology associated with these incidents. Incident analysis, action planning, tactical decision making, and the role of the local, state, and federal response plans are examined. Includes an 8 hour interactive tabletop exercise in which the students implement the incident command system to plan for and execute command functions at a WMD incident.
