Some items to note: Surplus furniture that needs to be removed that was in the hallway near the loading dock. HE – SE corner has an exposed electrical cord next to the ambulance. They are currently crossing the sidewalk. A guard for the electrical cord is needed. HW – fire protection system on the 2nd and 3rd floor west side has knobs that are reachable for everyone and there is concern that they can be tampered with. It was noted that there is a specialized tool to be able to turn/access these knobs. Safety Inspections at Wilsonville campus has been completed. Only item to note: Daisy chaining of some cords. Safety Inspections at Oregon City campus (22 buildings total) has been compelted with the exception of Pauling A-B-C, Streeter Hall, and Streeter Annex.
