Upcoming: 2020 Annual Hazardous Substance Inventory Report – due by March 1st (through Oregon Office of State Fire Marshal). COVID-19 national numbers update: Yesterday, set <u>daily</u> record for deaths since pandemic began (up 4,406; cumulative total 381,000)this <u>daily</u> number is more than 9/11 and Pearl Harbor; this cumulative total is only 25,000 less than WWII. Positive daily cases (up 230,000; cumulative total 23M); hospitalizations (131,000). 9M vaccinations so far. Coronavirus is now #1 leading cause of death in U.S., recently passing heart disease and cancer. Need to follow and maintain safety protocols.
