Injury/Illness/Incident Reports	Brian		 New injury reports since last meeting on October 16: (12). Five students, six employees, one 'other'. A student borrowed a knife from a classmate and cut themselves. They were provided with a bandage, and student opted to drive themselves to urgent care. A student was walking to Pauling from Wacheno and slipped on metal grate near the building. An employee was using clippers and sliced through their fingertip. A student accidentally triggered a welding gun and the wire heated up and burned their fingertips. An employee caught their shoe on a classroom chair. Fell and hit their chest on the corner of the chair, and head on the carpeted floor. A student was adjusting a bar on a welding booth, and the bar fell on her finger. An employee was lifting boxes of books. Three boxes that weighed 37lbs each and they hurt their back. An employee was moving items around on a shelf above their head and twisted their arm / shoulder. It sent shooting pain down their arm and into their finger. It initially went away, then came back later that night. They took themselves to urgent care. Employee stepped on a rock, lost their balance, and fell. Minor scratch on right forearm. 	Discussion Decision Advocacy Information Document

		 A community member was walking in the orange lot carrying multiple items. They tripped on the curb, fell and hit their nose. College Safety responded and provided an ice pack. A student was holding a crate with a knife in their right hand. When they went to set the crate down, the knife caught on their right pinky finger and cut down its side. An employee was removing a rusted bumper bolt on a vehicle. The bolt broke, alloweing their rachet to jump free and strike them above the left eye. 	
Questions, comments, discussion	Brian	 Completed: ceiling sprinkler pipe leak repait in S116, and other rooms checked for leaks; most deficiencies have been corrected that were found at recent annual sprinkler inspections (all sprinkler heads in 7 buildings tested passed); most fire extinguisher recommendations by United Fire done; spare nitrogen tank at ITC; new first aid kits in Automotive. Upcoming: remaining older sprinkler head swap-outs remaining at RR, Wilsonville; horn/strobe replacement at Wilsonville; external door replacements at FRC childcare to stop mice entry; working on confined space entry requirement protocol for outside contractors who work on our campuses. Ongoing: Monthly inspections of emergency eye washes & showers at Oregon City & Harmony campuses; IPM (pest control) as needed by both Custodial and Western Exterminator (mice, ants at this time); first aid kit restocks.
