Dr. Cook will explain the process, timeline, funding and other elements with CVIM.</li> <li>Some of the advantages of brining CVIM onto CCC campus were discussed as: <ul> <li>CVIM is a no cash/insurance medical facility</li> <li>CCC doesn't currently have a medical facility onsite</li> <li>This could be a training opportunity for CCC's healthcare students</li> <li>There is an opportunity to utilize CVIM for sports medicine (physicals, concussion checks, etc.)</li> <li>Potential Covid-19 testing?</li> </ul> </li> <li>There was a concern regarding safety and it was communicated that CVIM doesn't use any narcotic medication and they don't utilize cash.</li> </ul>	Discussion Decision Advocacy Information Document
