Insurance committee has been meeting weekly.  This is an all or nothing opportunity – if we buy into OEBB, there is no opportunity to get out.  We do have a choice on whether we join this year or sometime in the future.  Associations have requested a visit with each group to share and discuss this information. Capital Planning for next 3 years	<ul> <li>You may not accept gifts of entertainment (such as tickets to a sporting event, concert, movies, a round of golf, skiing, hunting, and fishing).</li> <li>There are penalties for violations</li> <li>NEXT STEP: Courtney will provide electronic copy to Association Presidents for distribution or discussion.</li> <li>Joanne Truesdell: The Executive Team met with Liz Kauffman on Friday to begin exploring the different stages of a capital planning campaign and what the key items would be over the next 6 months.</li> <li>Analysis of previous bond (2000) needs to be done: what did it purchase? What did it cost? Was it on budget and on time? What has happened as a result? What impact has it had on students? Community? Businesses and employers? Others?</li> <li>Master Planning for CCC needs to be done – what will CCC look like in 20 years (2030)? What will be funded with the next bond?</li> <li>Inventory existing facilities</li> <li>Timeline if there were to be a Bond election in 2010</li> <li>March-May '09: Vote from Board to approve moving forward with the Bond campaign</li> <li>July '09-Dec. '09: Community Outreach and listening to what they have to say</li> <li>Sept. '08: Analysis of Previous Bond completed</li> <li>Adopt guiding principles and goals – identify some that next bond would accomplish</li> <li>Review mission, vision and values</li> <li>Connect values to budget, facilities, equipment, etc.</li> <li>Engage community in discussions</li> </ul>
