Harmony: Community Plan Report

Shelly Parini presented the Harmony Community Campus Conceptual Master Plan (Handout #1). The report details discussions and community input regarding campus development. Harmony Community Campus (HCC) consists of four key partners who have been working together since 2006:

- Clackamas Community College (CCC)
- Oregon Institute of Technology
- North Clackamas Parks and Recreation District
- Clackamas County

These partners will continue to work together to implement the Conceptual Master Plan and will report progress to their constituencies, the community, and provide updates to the HCC Web site at www.harmonyvision.org. A unified visioning process (collaborative approach) with local community members will help to avoid long term problems or disagreements.

For the future:

- Clackamas County Parks continues to review the environmental water services and storm water detention impact
 upon the 100 acre natural park concept.
- Oregon Department of Transportation is considering traffic flow and roads; structured parking (multi-level parking) bordering 82nd and Greenline from Happy Valley to HCC and CCC – Oregon City Campus.
- CCC Capital construction and bond campaign

President Truesdell thanked Shelly Parini and CCC students for their involvement in building development plans/processes and community outreach efforts.

Consultation Report: CCC Web Page

(Handout #2) Terry Mackey reviewed the Web Committee, December 8, 2009, meeting minutes:

- Student Survey Top three problem areas identified and discussed:
 - o Webpage navigation
 - Search engine
 - Department web sites
- Institutional Activity #2: Redevelop the CCC web site to be interesting, inviting and easy to use for external constituents and provide internal constituents with stronger communication and easy access to information.
- The Web Committee passed a resolution to establish a *standardized* model for department web pages. Standardization (images, colors, navigation tools, and general page set-up to be the same) is the key to success.
- Green Grant dollars were used to launch this process (pay for a consultant from Training and Consulting Service for Non-Profits (TACS)).
- (Handout #3) The TACS report was presented and reviewed. It contains recommendations for the Website Redesign Strategic Plan.
- The report has been endorsed by the Campus Web Committee.
- The Web Committee recommended the Administrative Project Management Team to be Shelly Parini, Steve Beining and Joe Austin.

Items to clearly define:

- Roles, guidelines and standards driven by the Executive Team leadership
- Our goals to keep our institution viable
- Training needs
- Simple navigational processes (easy access for external constituents)
- How many power-users are needed and who they might be
- Who the administrators/experts would be

Next Steps:

- Initiate discussions: Continue to disseminate results of the TAC study to College Council (CC) and other campus constituencies for input and review and to explore options for proceeding with recommendations.
- Administrative Project Management Team was endorsed by Presidents' Council (PC) members to continue
 research by going out for a Request For Proposal (RFP); this is key in obtaining further information regarding
 associated costs.
- Administrative Project Management Team will return to PC and CC with findings from the RFP.
- Shelly Parini, Joe Austin, Janet Paulson, and Terry Mackey will communicate the initiation of IA #2 to CC on 1/15/10 and report back to PC on 1/19/10.
