Student Handbook

A few changes are planned for the student handbook this year.

- Students rights and responsibilities: Formal and informal processes for problem resolution will be updated and clarified. Past process has included a third step of a hearing. This is being researched to determine if it is a legal and/or an appropriate step within this process.
- Problem resolution and student code of conduct processes will be clarified regarding the formal and informal processes, when to turn in the Problem Resolution Form, and who to talk/meet with.
- Discipline processes related to code of conduct will be updated to include three associate deans or designee.

Next Steps:

Elizabeth Lundy will be sending out a draft soon, reflecting handbook changes planned. Courtney Wilton will arrange for OIT floor plan (location of CCC classrooms) to be added to the student handbook.

Community Meeting Update

May 23 / 6-8:00 p.m.: Courtney Wilton, Shelly Parini and Bob Cochran attended an open house where the public was invited to come and talk with staff and consultants to share ideas for specific design of the proposed extension of Sunnybrook Boulevard west from 82nd Avenue to Harmony Road. The county is considering building the extension sometime in 2013. This road would cut through the back side of the Harmony Community Campus and help smooth out traffic movement. Harmony Community Campus is part of a 20-year regional transportation plan. Clackamas Community College and the county worked together with the community for one year to develop a unified visioning and collaborative process/effort where guiding principles were developed. Some of the issues discussed included:

- mitigating the preservation of 3-Creeks area and white oak trees;
- water environmental services;
- storm water detention areas;
- soft recreation uses;
- changing the planned 4-lane road to a 2-lane road;
- removal of 40 trees; and
- development of a shared green vision including strategic and environmental positives involving MAX/light-rail and the burning of less fossil fuel.

May 18 / 6-9:00 p.m.: Clackamas Community College hosted the Clackamas County Community Congress in the Gregory Forum. The purpose of the meeting was to continue and strengthen our relationship between Clackamas County citizens and the Board of County Commissioners.

Commissioners have been discussing the possibility of a Concordia presence in Oregon City. Their core focus is service learning and connection to community. As business incubation supporters they want to help people

develop innovative businesses, business capital, and create a pathway to a four-year degree. Concordia is pursuing a partnership with Oregon City.

Accreditation

Elizabeth Lundy gave an overview of year one and year three reports due to NWCCU by Fall 2011 and Fall 2012 respectively. Elizabeth discussed revised standards 1-5. The accreditation cycle will take place over a 7 year cycle through 4 separate reports. As they phase in the new process, they have modified the cycle so that the schools would be staggered through the process. CCC has a condensed five year (instead of seven year) cycle this first time through. The first report is due the middle of September. Accreditation reporting will be a continuous cycle. As we move through each evaluation cycle we will be revising reports submitted in the previous year. See attached powerpoint coded 05.24.11-Handout #1 for details.
