In spring 2017, the Diversity Task Force created a charter for a standing Diversity Committee, which will be distributed to the members of the Diversity, Equity and Inclusion Committee.

The Executive Team and Presidents' Council reviewed the charter, and made changes:

1. The standing Diversity Committee will be named the Diversity, Equity and Inclusion Committee.
2. The President has delegated to the Diversity, Equity, and Inclusion Committee the institutional role of establishing the processes related to cultural competency standards, as required by House Bill 2864.
3. The Diversity, Equity and Inclusion Committee reports to President Joanne Truesdell and the Presidents' Council.
4. The President has delegated the role of sponsor of the committee to Vice President David Plotkin, who will also serve as liaison to Presidents' Council and Executive Team as needed. The role of sponsor:
 - Convene the Committee in fall 2017.
 - Provide the charter developed by the Diversity Task Force.
 - Oversee the progress of the committee, especially as related to HB 2864.
 - Consult with the committee chairs or the committee as a whole as needed.
 - Report on the progress of the committee to the President and the Board of Education.
5. The membership of the committee has been modified. Membership will include at least:
 - Two Classified Association representatives
 - Three Full-time Faculty Association representatives
 - One Part-time Faculty Association representative
 - One student representative
 - One representative from Human Resources
 - One Admin/confidential representative
 - One Leadership Cabinet representative
 - One representative from the Disability Resource Center, or a representative with responsibility for ADA compliance
 - One representative for Veteran's Services

Other aspects of the charter developed for the standing Diversity, Equity and Inclusion Committee will remain as created by the Diversity Task Force.
