CCC Land Acknowledgment

We acknowledge that the Clackamas Community College campuses reside on the traditional homelands of the Clackamas, Cascades, and Tumwater bands of Chinooks, as well as the Tualatin and Pudding River bands of Kalapuya and the Northern Molalla people. They lived and prospered by maintaining strong cultural ties to the land, and through wise management of resources. As signers of the Willamette Valley Treaty of 1855, they were removed from their homelands to the Grand Ronde Indian Reservation where they became members of the Confederated Tribes of Grand Ronde. Please join us in taking this opportunity to thank and honor the original caretakers of this land, their lives, and their descendants that live on as Tribal members today, still carrying on the traditions and cultures of their ancestors.



Labor Acknowledgment

We also acknowledge that our nation has benefited and profited from the free enslaved labor of Black people. We honor the legacy of the African diaspora and Black life, and the knowledge, skills, and human spirit that persevere in spite of violence and white supremacy.

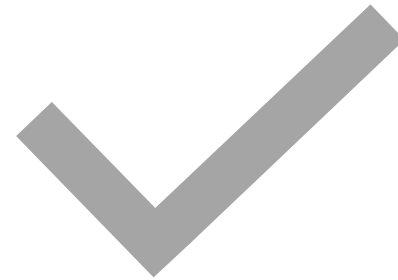

 - Includes the mission statement, vision and goals.

- First Priority: Institutional Knowledge Management
 - Foundational topic that impacts future work of the group
 - High-need priority as evidenced by People & Culture retreat
- Priority aims to answer: Where should employee Information live?



Student Support

Student Support – 24/25 Priorities

Holistic Student Support -

- Review and confirm or reestablish metrics, in alignment with key indicators, to measure current efforts in collaborating with students both in and out of the classroom to understand and respond to their needs and goals.
- The focus in year one is to gain a deeper understanding of the data.



Student Support – 24/25 Priorities

Strategic Enrollment Management (SEM) Plan -

- Build awareness of the status of the college's current SEM plan, communicate SEM plan updates and progress, and identify meaningful broader reaching metrics.
- Close out current SEM plan & utilize learning to influence the development of our next iteration.



Student Support – 24/25 Priorities

Student Policy Oversight –

- Collaborate and create a revised/new policy committee with Instruction Standards and Policy (ISP) committee.
- Develop a process for policy review, approval, and feedback.
- Inform the college community of policy updates.
- Move existing Access, Retention, and Completion (ARC) policies to this newly formed committee.

Finance Council: Priorities for 2024-2025

- Budget Advisory Subgroup (BAS)
 - Formed at the beginning of the term
 - A 21-member advisory group consisting of the Finance Council plus representatives from across the college affiliated with the other shared governance councils
 - Currently reviewing proposals to address a \$3M structural deficit

Finance Council: Priorities for 2024-2025

- Conducting foundational work for future financial policies
- Develop Fund Statements of Use and Purpose of the college's 22 different funds
- Provide consistent information for sources and expenses, including reserves and contingency usage

Finance Council: Priorities for 2024-2025

- Explore Business Office policy gaps & address opportunities to improve services
- Example:
 - Implement Amazon Business Account
 - Transition so check runs are consistent throughout the academic year
 - Utilize efficient procurement practices
 - Conduct assessment of current operational financial policies

Operations Council

The College Operations Council is focused on the maintenance and improvement of our buildings, grounds, technology infrastructure, and safety planning.

Operations Council – Get involved



- First meeting of the month is open to all
 - We share committee news, decisions, and developments
 - We ask for stakeholder contributions and ideas
- Second meeting of the month is a closed work session where we work on details and strategy with invited stakeholders and council members



What has Operations been up to?

- Our public meetings are recorded! They are found in the Operations council page under meetings.
- Standing topics are:
 - Bond updates
 - Committee reports
 - Data / ITS support
 - Infrastructure and facilities
 - Oversight Group recommendations as they come down



The big 3 things we are working on

1. **The Bond:** Constantly moving forward
2. **ITS support:** Identifying priorities and communicating updated policies around cyber security and our technology
3. **Facilitating improvements:**
 - Do you know about our injury report forms?
 - Emergency planning taskforce
 - We've responded to a student led Initiative for food service. This was a test of our processes and it works!



Oversight Group

Tasked with providing feedback and making recommendations to councils when needed, this group has been a sounding board for ideas and a space to ensure consistency within the Shared Governance process.



The Oversight Group has paws in:

- Helping find the right workgroup for tasks.
- Ways to improve the process of Shared Governance as Oversight Group meetings are where co-chairs address concerns. When there are rough spots we can pass it on to the Process Support Council.



Additional Oversight Group Activities:

- Reviewing the priorities of councils and giving feedback. The diversity of individuals and roles in the group can help redefine and improve council priority list with metrics.
- Consideration of how we improve college wide communications and updates. Both the critical info like your responsibilities around Cybersecurity and the non-critical but equally important updates on what is happening on campus and where...
