### **Communicating Expectations**

- All students are expected to follow the Social Distancing policy while participating in campus activities as part of following the <u>Student Rights</u> <u>and Responsibilities</u> as outlined in the student handbook.
- As part of setting expectations about the Social Distancing policy, the College will broadly communicate the requirements to the campus community via email, web, and on-campus signage.
- Faculty and staff can also assist students in being aware of Social Distancing expectations by providing specific instructions in course syllabi, by utilizing activity participation agreement forms, by telling students directly about the expectations, and by providing an opportunity for non-compliant behavior to be corrected.



### **Requests for Accommodations**



- Some students may express a need for alternatives to the identified Social Distancing policy for a disability and should be referred to the <u>Disability Resource Center (DRC)</u> to be assessed for accommodations as appropriate.
- If a reasonable accommodation is required, an interactive process is being considered that would include faculty.
- Students whose needs cannot be accommodated for campus-based activities may be referred to online options.





CCC Student Conduct & Disciplinary Policy

Pg. 161 Student Handbook Section B. Behaviors or actions that are disruptive, distracting, or disorderly including but not limited to:

- 1) Obstruction or disruption of teaching, classroom, research, administration, disciplinary procedures or other authorized college activities including obstruction or disruption interfering with freedom of movement. Conduct that disrupts the educational environment can result in immediate removal from class and/or activity or Summary Suspension (See Article VI);
- 4) Physical abuse or detention of any person, or conduct which intentionally or negligently causes harm, or is intended to threaten imminent danger to the health of any person; and
- 11) Failure to comply with directions of college officials acting in the performance of their duties; inciting others to engage in any of the conduct, or to perform any of the acts, prohibited in this Code.

#### CCC Student Code of Conduct Making a Referral

- A student who does not have a college-confirmed accommodation, and refuses to follow the Social Distancing policy after they are reminded to do so by a College official, could be in violation of the student Code of Conduct.
- As with all regulated student behavior, a student who does not comply with the Social Distancing policy can be required to leave the class or activity for that session and be referred to the Conduct Team for a conduct review as part of the disciplinary process prior to returning to class.
- College Safety personnel are available to assist staff, faculty, and students with maintaining Social Distancing policy as appropriate.



CCC Student Code of Conduct – Student of Concern Form

- An instructor or staff member who is concerned about student non-compliance should submit the online <u>Student of Concern form</u> as soon as possible after an incident to request a Code of Conduct review.
- When submitted, this form will automatically be directed to the CARE Team and triaged to the appropriate Conduct Officer (division Associate Dean) for follow-up.
- Student of Concern forms should be submitted as soon as possible after any relevant event or behavior occurs.



## **Conduct Team**

- The Conduct Team is comprised of the three Associate Deans involved in reviewing and adjudicating potential violations of the CCC Code of Conduct.

- The team meets as needed to review conduct cases and discuss potential sanctions that are consistent across the divisions.
