The subcommittee presented the recommendation that before an Instruction and Student Policy was adopted, there needed to be a more general, board-level policy about Generative AI. The draft policy and recommendation were discussed. The Council considered various issues and concerns about Generative AI in higher education, including ethical concerns. The Council reached consensus that there was a need for a board-level policy, and agreed to forward that recommendation on to the People and Culture subgroup working on policy and to Kattie Riggs, Executive Assistant to the President and the Board of Education.</p> <p>There were no other committee reports.</p>	David Plotkin committed to bringing the Council's recommendation to the People and Culture Council and to Kattie Riggs.
